➤ **Cancellation and No-Show Terms for Short and Long Stay**

Daily Booking	
Cancelling the booking 24 hours or less prior to the check-in date or during the stay.	One night will be charged.
Weekly Booking	
Cancelling the booking 48 hours or less prior to the check-in date or during the stay for bookings between 7 to 29 nights.	Non-Refundable.
Monthly Booking (30 Nights)	
Cancelling the booking 30 days prior to the check-in date.	Refundable
Cancelling the booking 15 to 29 days prior to the check-in date.	Security deposit will be charged.
Cancelling the booking 14 days or less prior to the check-in date or during the stay.	One-month fee will be charged.
Annual Booking (365 Nights)	
Cancelling the booking more than 15 days prior to the check-in date.	One-month fee will be charged.
Cancelling the booking 15 days or less prior to the check-in date.	One-month fee and security deposit will be charged.
Cancelling the booking on the arrival day or during the stay.	Charging one month fee and security deposit within the first 6 months. Charging half month fee and security deposit after 6 months. Note: One-month notice is required.

In case of direct payment by the guest, non-guaranteed bookings are to be released 24 hours prior to arrival until 4:00 PM for booking between 1 to 6 nights.

If the above deposits are to be shouldered by the company, the same must be made prior or upon check-in of the guest. If unused/consumed, these deposits are refunded upon check-out, in the same mode of payment made.




➤ **Check-In and Check-Out Policy for Short Stay**

- Check-in time is 2:00 PM and check-out time is 12:00 noon.
- Early check-in from 8:00 AM until 12:00 noon will be charged 50% of the contracted rate.
- Check-in up to 6:00 AM, one (1) night at the contracted rate will be charged.
- Late check-out from 12:00 noon until 6:00 PM will be charged 50% of the contracted rate.
- Check out after 6:00 PM, one (1) night at the contracted rate will be charged.
 - * Above are subject to availability.

➤ **Children Policy**

- Rooms
 - Children from 1 to 12 years old stay for free if sharing parent's room and having the same meal plan for maximum 2 children.
 - Baby cots are free of charge and subject to availability, for stay 1 to 7 nights only.
 - Rollaway beds are available at QAR 150 per night and subject to availability, for stay 1 to 7 nights only.
- Food and Beverage
 - Children from 1 to 6 years old are free of charge.
 - Children from 6 to 12 years old will get 50% discount on F&B.
 - Children 12 years old and above, all meals will be charged as per the price list.

➤ **Visa Procedures and Requirements**

The Hotel will facilitate visas for guest/s staying with us during their entire stay. Reservations must be guaranteed by credit card or advance cash deposit. The Hotel will require 5-7 working days for the release of the tourist visa as it is subject to approval by the authorities. The following are the required documents:

- Clear scanned copy of passport (must be valid at least 6 months).
- Visa fee of QAR 500 per person which is non-refundable and advance room deposit or company P.O.
- Payment thru credit card.
- Scanned copy of credit card (both sides).
- Signed credit card authorization form along with a valid passport copy of the card holder.
- Signed letter of guarantee and valid ID of the responsible person.
